Infomerics Credit Rating Nepal Limited (Infomerics Nepal) has withdrawn the rating of IRN B+/A4 'INC' (Single B Plus/A Four, Issuer Not Cooperating) assigned to long term/short term bank facilities of Nepalirika Hotel Private Limited (NHPL) with immediate effect.

#### **Detailed Rationale**

The rating action has been taken in accordance with Securities Board of Nepal (SEBON) guidelines, following non-cooperation from NHPL for rating surveillance, despite multiple follow ups. Prior to this withdrawal, the ratings were kept in the Issuer Not Cooperating category with notice of withdrawal for a period of six months. During this period, there was continued non-cooperation from the company for rating surveillance, and hence, the key rating drivers, rating sensitivities, and key financial indicators have not been captured due to the unavailability of adequate information.

The hotel is managed by Crimson Hotel Private Limited, India.
